Sunshine Law Under the federal "Sunshine Law", all medical device and pharmaceutical manufacturers, including Smith & Nephew, are required to track and report payments and transfers of value provided to US-licensed physicians and teaching hospitals annually. The information must be submitted to the Centers for Medicare & Medicaid Services (CMS) by March 31. CMS then posts the reported data on their Open Payments website, which is a publicly available website. Smith & Nephew is committed to full compliance with the Sunshine law. In order to comply, we will report payments and transfers of value provided to US-licensed physicians including the following as required by the Sunshine Law:

- Transportation expenses
- Lodging or accommodations
- Meals
- Other items that have an independent value
- Certain educational materials (e.g. medical textbooks and journal reprints; Smith & Nephew published items are not reportable)
